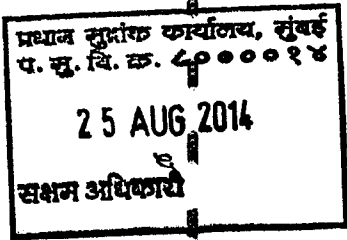

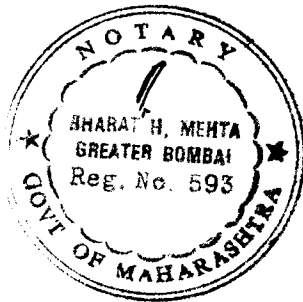

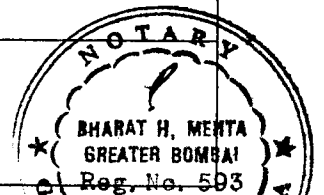

It is alleged in the FIR that on 3-3-2005 the Jharkhand Governor had given the oath to Shri Shibu Soren as Chief Minister of Jharkhand and Police got some information that a gathering of Bharatiya Janata Party workers would assemble at Azad Maidan to protest this move and shouts slogan and hence this case was registered.

It is alleged in the FIR that on 4-10-2006 information was received by the police that a gathering under the leadership of President of Yuva Morcha BJP, Party workers would gather at Churchgate Railway Station to protest the speech of Chief Minister Gulam Nabi Azad against the award the death sentence to Afzal Guru, who had attacked the Parliament House and shout slogans and protests to condemn the Chief Minister's Speech and therefore there was heavy Police Bandobast at Churchgate Railway Station. It is further alleged that around 30 to 35 party workers gathered at Churchgate Railway Station and protested and raised slogans and therefore the case came to be registered.
